## WAIVER, RELEASE AND ASSUMPTION OF RISK AGREEMENT FOR PLAYERS AND PITCHERS

In consideration of being allowed to participate in any way in the Sylvania Recreation Corporation(SRC) athletic/sports program, Sylvania Senior Softball League (SSS), Sylvania Area Joint Recreation District (SAJRD), related events and activities, the undersigned acknowledges, appreciates and agrees that:

- 1) The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist. Further, a pitcher, whether a starting pitcher or one who replaces the starter pitcher in mid-game, or during practice sessions, acknowledges, appreciates and agrees that I have been warned by the above mentioned entities that the position of pitcher carries additional risk of serious injury, including death; and
- 2) As a pitcher I have been advised, encouraged and warned to wear protective headgear and shin guards at a minimum for bodily protection while pitching during games and/or practice sessions with any softball activity under the above mentioned entities, SRC, SSS, SAJRD. I understand that it is the official position of Senior Softball USA, SRC, SSS and SAJRD that protective gear is to be worn by pitchers at all times while pitching; and
- 3) Pitching screens have been added to the playing fields for added protection for the pitchers. These screens are mandatory for practice sessions as well as games before any play shall begin. Once the pitcher releases the ball, he is to use the screen for protection so as not to be hit by a batted ball; and
- 4) I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and
- 5) I willingly agree to comply with the stated and customary conditions for participation. If I observe any unusual significant hazard during my presence, I will remove myself from participation and bring such unusual or hazardous activity to the attention of the nearest facility official immediately.
- 6) I, for myself and on the behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE SYLVANIA RECREATION CORPORATION, SYLVANIA AREA JOINT RECREATION DISTRICT, SYLVANIA SENIOR SOFTBALL, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of the premise used to conduct the event ("Releasees") WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
- 7) I, for myself and on the behalf of my heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all of the above Releasees from any and all liabilities incident to my involvement or participation in these programs, EVEN IF ARISING FROM THEIR ALLEGED NEGLIGENCE.

I HAVE READ THIS RELEASE AND/OR LIABILITY AND ASSUMPTION OF RISK AGREEMENT, AND I FULLY UNDERSTAND ITS TERMS, AND I FULLY UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
